CONSIGNOR'S CONTRACT

Total Entry Fee:	Non-refundable , GST included \$393.75 (Yearlings, Broodmares, Weanlings, Horses of Racing Age) \$210.00 (Stallion Shares)
Halter:	To be invoiced at cost plus applicable taxes after sale.
Commission:	5% of reserve or accepted bid on horses, with a minimum commission of: \$150 per horse sold, not sold, or withdrawn without a vet certificate; \$80 per stallion share sold or not sold.

NOMINATION DEADLINE: Friday, May 22, 2009

REQUIREMENTS:

- Only members of the C.T.H.S. may consign to these sales.
- Yearlings, weanlings and HORA consigned to this sale must be Canadian-bred and Canadian registered.
- All entries must be in writing and signed by the consignor or his/her authorized agent.
- The halter goes with the horse. Consignor is responsible for cost of halter whether horse is sold, not sold, or withdrawn.
- If a reserve is desired by the consignor, said reserve shall be given to the auctioneer at announced consignor's meeting or as specified in "Consignor Reserve Rules".
- If a horse is withdrawn, minimum commission will be charged. This charge will be waived upon receipt of a veterinary certificate within 10 days of the withdrawal date.
- Only Canadian Registered horses, which are catalogued and have all CTHS nomination fees and commissions, paid in full are eligible for the Sales Stakes. A commission will not be charged for horses withdrawn from the sale with a vet certificate.
- DNA for weanlings must have been processed a month before the sale date.
- Registration papers for **ALL** entries must be in the C.T.H.S. office 10 days prior to the sale or entries will be required to be withdrawn from the sale.
- Consignors will be paid within 20 days after the C.T.H.S. has received payment for the consignment sold. However, the C.T.H.S. reserves the right to extend this deadline if necessary.
- **Horses will not be offered for sale without negative coggins.**

DOCUMENTS REQUIRED FOR SALE:

- Original Jockey Club Registration Certificate for each horse
- Original Canadian Registration Certificate for each horse (if applicable)
- Original Coggins Test (dated within 6 months of sale)

- Colt/Ridgeling Form
- Stallion Service Certificate
- Breeding Status Certificate
